## Terms and Conditions

1. All reservations must be confirmed with a non-refundable booking fee of \$400. The balance owing is required 60 days prior to the event and can be paid by cash, Cheque or direct deposit. All Booking charges and payments are nonrefundable only under extreme circumstances.
2. Lead Sled Limousines reserve the right to terminate any and all services due to unruly or abusive passengers without a refund. The -hiring customer will be held responsible for the conduct of all the passengers in the vehicle at all times.
3. Lead Sled Limousines operate a "NO SMOKING" policy within all their vehicles. Should this condition be ignored the driver is authorised to terminate the hire agreement and a refund will not be offered under any circumstances.
4. Any damage or breakages caused during the hire will be charged to the hiring customer, including fabric damage, spillage, soiling. A \$400 cleaning fee will apply to any soiling. Broken glasses are charged at \$4.00 per glass.
5. Overtime rates of \$100 per 15minutes will apply for extended hire over and above the time agreed upon, as per the hire agreement.
6. All passengers must wear seatbelts as per current legislation. No food is to be consumed in the vehicle.
7. Due to the length of the new stretch limousines, access into some suburban streets may be restricted and pickup/drop offs at front door may not be Achievable. Drivers reserve the right to refuse passage to any venue that they deem unsafe to the vehicle or passengers.
8. Hire agreements can only be made by and adult over 18 years of age
9. Overtime rates may be charged @ discretion.
10. Fees are calculated on the chosen vehicle based on an hourly rate
11. Minimum 1 hour for all bookings
12. Parking fees, road tolls, and airport fees will be charged back to the client.
13. Hourly rates are subject to change however written notice will be given
14. Lead Sled Limousines will issue you an invoice for services rendered. Payment is required 7 days of invoice date.
15. All bookings and cancellations are only confirmed when written notice is received, no later than 24 hours prior to the charter date to cancel your charter.
16. We endeavor to provide the vehicle requested though in the unlikely event that we are unable to do so, we reserve the right to provide a substitute vehicle of similar capacity or upon client's request a full refund
